

## RELEASE FROM LIABILITY

THIS AGREEMENT and RELEASE, dated this \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, by and between WILDLIFE RESCUE TEAM, INC., a Nebraska non-profit corporation hereinafter referred to as "Wildlife Rescue Team" and \_\_\_\_\_ and \_\_\_\_\_, as an individual(s) or as parent(s) and/or natural guardian(s) of \_\_\_\_\_, minor child(ren) hereinafter sometimes referred to as "Volunteer(s)" or as "Minor Volunteer(s)", as the case may be;

WITNESSETH:

WHEREAS, Wildlife Rescue Team has been organized for the purpose of rescue, rehabilitation, and release of birds, fish, mammals, amphibians, and reptiles, and WHEREAS, in pursuit of its goals, Wildlife Rescue Team obtains the assistance of numerous unpaid volunteers who express their love of and concern for America's wildlife by participation, without financial compensation, in the wildlife rescue, rehabilitation, and release program sponsored and supervised by Wildlife Rescue Team, and WHEREAS, the goals and programs of Wildlife Rescue Team could be seriously threatened or even curtailed if Wildlife Rescue Team were to be sued by volunteer(s) or their legal representatives who may sustain injuries from any cause during their participation in the Wildlife Rescue Team program, and WHEREAS, volunteer(s) desire to minimize the possibility of the occurrence of any such lawsuits,

NOW, THEREFORE, for and in consideration of the mutual promises and covenants contained in this Agreement and Release, the parties hereto agree as follows:

FIRST: The undersigned person(s) agree that they are the sole parent(s) and/or natural guardian(s), having legal custody of \_\_\_\_\_, minor child(ren) volunteer(s).

SECOND: In consideration for the opportunity afforded said volunteer(s) and/or minor volunteer(s) to participate in the Wildlife Rescue Team program and thereby obtain a greater knowledge of and appreciation for America's wildlife, they hereby agree that they are assuming any and all risks concomitant with said participation and that they shall bear all financial and/or other burdens which may occur as a direct or indirect result of said volunteer(s) and/or said minor volunteer(s) being injured, in any way, while participating in the Wildlife Rescue Team program; and that, under no circumstances, will they present a claim or file a civil lawsuit against Wildlife Rescue Team on account of any loss or damages, of any type, sustained by them as a result of their participation and/or minor volunteer(s)' participation in the Wildlife Rescue Team program.

THIRD: In an effort to minimize the likelihood of any injury to volunteer(s) and/or minor volunteer(s), Wildlife Rescue Team agrees to provide full initial and adequate supplemental instructions to volunteer(s) and/or minor volunteer(s) with respect to the rescue, rehabilitation, and release of any and all wildlife in the custody of said volunteer(s) and/or minor volunteer(s).

FOURTH: In the event that any volunteer(s) loses custody of a minor volunteer(s) during the existence of this Agreement, then such volunteer(s) agrees to notify Wildlife Rescue Team, in writing, of such change in said minor volunteer(s) custodial or guardianship status.

FIFTH: This Agreement shall remain in effect as long as any volunteer(s) and/or minor volunteer(s) continue to participate in the Wildlife Rescue Team program.

SIXTH: This Agreement constitutes the entire agreement between the parties hereto. It may not be cancelled or amended except by written agreement between the parties executing this Agreement or their legal successors in interest.
